Public Notice of Proposed Rule-Making Regulations Governing the School Calendar and Length of the School Day

Pursuant to the provisions of Chapters 16-21-34 of the General Laws of Rhode Island and in accordance with the Administrative Procedures Act Chapter 42-35 of the General Laws, the R.I. Department of Elementary and Secondary Education hereby gives notice of its intent to revise the Board of Regents Regulations Governing the Length of the School Day.

The proposed revisions were approved by the Council on Elementary and Secondary Education for the purpose of public review and comment. The proposed revisions clarify, simplify, update, and improve the existing regulations by eliminating the confusion and contradictions regarding delayed school openings and early dismissals.
